 - 2. The decision enters into force on the day of its adoption.

Explanation

With the decision of the Director General, it has been initiated the procedure for the selection of the Contractors for the project of the reconstruction and modernization of the railway line "Nis - Dimitrovgrad – section Prosek (Sicevo) – Dimitrovgrad".

The notice of public bidding for the concerned Contract was published in the Official journal of the European Union.

3.3 Financial evaluation

Determination of the amount of the financial offers

The evaluation committee checked all tenders for arithmetic errors.

As stated in the instructions to tenderers, arithmetic errors were corrected on the following basis:

- Where there was a discrepancy between amounts in figures and in words, the amount in words prevailed;
- Except for lump-sum contracts, where there was a discrepancy between a unit price and the
 total amount derived from the multiplication of the unit price and the quantity, the unit price
 as quoted prevailed, except where the evaluation committee agreed that there was an obvious
 error in the unit price, in which case the total amount as quoted prevailed;
- Where unconditional discounts applied to financial offers for individual lots, the discount was applied to the financial offer.

The arithmetically corrected financial offers were compared to identify the technically compliant tender with the lowest price.

The tender submitted by China Civil Engineering Construction Corporation appeared to have an abnormally low price in relation to the market for several items in question. Consequently, the chairperson of the evaluation committee wrote to Tenderer number 1, China Civil Engineering Construction Corporation to obtain a detailed explanation for the low price proposed (see Appendix

4, pages 10 - 17). On the basis of the response of the tenderer, the evaluation committee decided to accept the tender because the tenderer used an economic production method.

Tenderer number 5, China Railway 21st Bureau Group Co. Ltd and China Railway Design Corporation, and tenderer number 6, GULERMAK, YUKSEL PROJE and PROMOTA, were technically non-compliant, hence, not ranked in the table below.

Furthermore, the Tenderer No. 5 (China Railway 21st Bureau Group Co. Ltd (leader) and China Railway Design Corporation) accepted the proposed adjustment for the found arithmetic errors, identified by the Evaluation Committe (please see Appendix 4, page 597), but the Tendered did not confirm that they had included in the tender the works listed under the Corrigendum 2 (please see Appendix 4, pages 597 - 598 and 600 - 601 (Query No 2 and Query No 3)). The response received from the tenderer is in a direct breach of clause 20.1 of V1-S1 and clause 3.7.12 para 1 of EIB GtP, and as such has been rejected by the Evaluation Committee.

3.4 Most economically advantageous tender
